

Terms and Conditions of Purchase
Volkswagen Group Charging
GmbH/ General Purchasing Division
(current as of 23 October 2024)
("VWGC Terms and Conditions of
Purchase")

1. Relevant terms and conditions

The legal relationship between the contracting partner and Volkswagen Group Charging GmbH, Karl-Liebknecht-Straße 32, 10178 Berlin, represented by its management, listed in the Commercial Register of the Charlottenburg Local Court under HRB207272 (hereinafter "ELLI") shall be governed by these VWGC Terms and Conditions of Purchase.

All amendments and supplements must be in writing.

Other general terms and conditions shall not apply even if they have not been expressly contradicted in individual cases.

2. Applicability of the Terms and Conditions of Purchase

These VWGC Terms and Conditions of Purchase shall apply together with the General and Special Terms and Conditions of Purchase of Volkswagen AG, General Purchasing Division, which are included in the respective individual case, with the following conclusive amendments:

2.1

"Volkswagen AG", "VW AG", and "VW" shall be replaced by "ELLI" in the respective General and Special Terms and Conditions of Purchase of Volkswagen AG.

2.2.

In addition to the inseparable contractual components listed in the General and Special Terms and Conditions of Purchase

of Volkswagen AG, these VWGC Terms and Conditions of Purchase shall form the contractual basis, whereby these VWGC Terms and Conditions of Purchase shall take precedence over the General and Special Terms and Conditions of Purchase of Volkswagen AG, even if the General and Special Terms and Conditions of Purchase of Volkswagen AG are more recent.

2.3

The place of performance shall be the delivery address specified by ELLI. If no delivery address has been specified, the place of performance shall be Wolfsburg.

3. Differing regulations

By way of derogation from the General and Special Terms and Conditions of Purchase of Volkswagen AG, the following provisions are amended below:

3.1. Contract components

Specifications for Production Equipment 1.01 only applies insofar as it is necessary and applicable for the respective performance.

3.2. Delivery note

The particular delivery guidelines of the place of performance shall apply.

3.3. Duty to inspect, notification of defects

Insofar as the customer has an obligation under the law to inspect the delivered items and give notice of defects, it shall be deemed sufficient if the customer gives notice of obvious defects within four (4) weeks of delivery/handover and other defects within four (4) weeks of their discovery.
